



Crawley District Scouts Stanford Campsite SUPPORTERS 100 CLUB CONSTITUTION

1. **Membership**

Membership is open to adults above the age of 18. Adults can hold more than one number should they wish to do so.

2. **Number of Members**

Not Limited

3. **Subscription**

a) The monthly subscription is £5, payable by standing order between 1st & 20th monthly. Annually or bi-annually in advance can be by cheque or bank transfer.

4. **Benefits**

(a) Monthly - A ballot of all paid up members will take place on the last Monday of each month, using an independent random number generator in the presence of the 100 Club organiser and an independent scrutineer. The first number selected will win the 'monthly prize' of £50, with three additional prizes; 1 x £20 and 2 x £15.

(b) Any Member who has more than one of their numbers selected in any one month will be entitled to receive all winnings as per the independent random number generator selection.

(c) The Membership participating in the benefits shall be governed by the provisions of paragraph 11 below.

(d) The prizes may be augmented or varied at the Committee's discretion, subject to the fact that at least 20%, but no more than 33% of the annual receipts from subscriptions shall be distributed among the members as prizes.

5. **Running Expenses**

The primary objective of the 100 Club is to raise funds to maintain and improve the running of Stanford campsite. Accordingly, expenses are to be kept to an absolute minimum.

The following expenditure is authorised:

- (a) Postage of winners' cheques
- (b) Upkeep of Bank Account.

Every month, and at the end of each calendar year a summary of winning numbers will be published on the Crawley District Scout website.

6. **Management**

Any questions, interpretations or disputes shall be directed to and decided by Members of the Crawley District Scouts Executive Committee. Should any Member of the said Committee be involved in any way in the matter to be settled, he or she shall, at the Committee's discretion, not participate in any decision made in respect of that matter.

The Treasurer of the Stanford 100 Club will maintain the accounts and have the authority to draw cheques on the Club's account. The Treasurer shall keep a roll of Membership and each member shall be allotted a roll number. The Committee shall have the power to disburse any financial surplus accruing to the Club, such disbursements being always for the benefit of the Stanford Campsite.

7. **Ballots**

Only paid up members shall be entitled to participate in ballots. The ballots to be organised as follows:

- (a) All members to be allotted, on subscription, a number corresponding to his/her number on the Group Roll.
- (b) All numbers to be entered for the draw via the independent random number selector (subject to Paragraph 10 below)

8. **Members Agreement on Joining**

So that the prizes, benefits and funds may be guaranteed, those joining are required to guarantee to give two months notice if they wish to leave. A provision to this paragraph is that, subject to approval by the Committee, a member may leave immediately if he/she introduces a new/alternative member.

9. **Accounts of the Group**

All members shall have the right to inspect the books of the Club on reasonable prior notice being given.

10. **Supplementary provisions for members joining during the year**

Whenever a member is enrolled, and upon receipt of his/her subscription, the Treasurer shall issue him with a membership number on the Group Roll and the date of enrolment. Subsequent to enrolment, the member shall be entitled to participate in monthly draws referred to in paragraph 4 (a).

11. **Closing the scheme**

The Committee will give 2 months notice if it intends to close the 100 Club.
